Income is based upon all money available for tuition. Documentation includes:

- 2023 income tax return for parents/guardians as filed with the IRS (W-2's, Form 1040, and **All Schedules**)
- If income tax extension is filed for 2023, then your 2022 income tax return as filed with the IRS with a copy of the extension request will need to be provided, pending your 2023 tax return being completed.
- Divorce decree (child support, separate maintenance) and/or State Attorney child support documentation, if applicable
- Social Security Statements, if applicable.

**To qualify for Categories 1-5, the above referenced documentation must be provided through FACTS Grants and Aid or else families will be placed in Category 6.**
